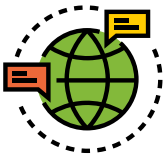

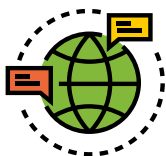

IGNITION PARTNERS NETWORK

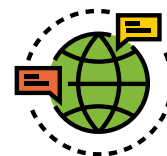

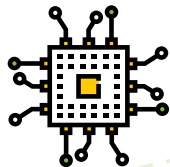

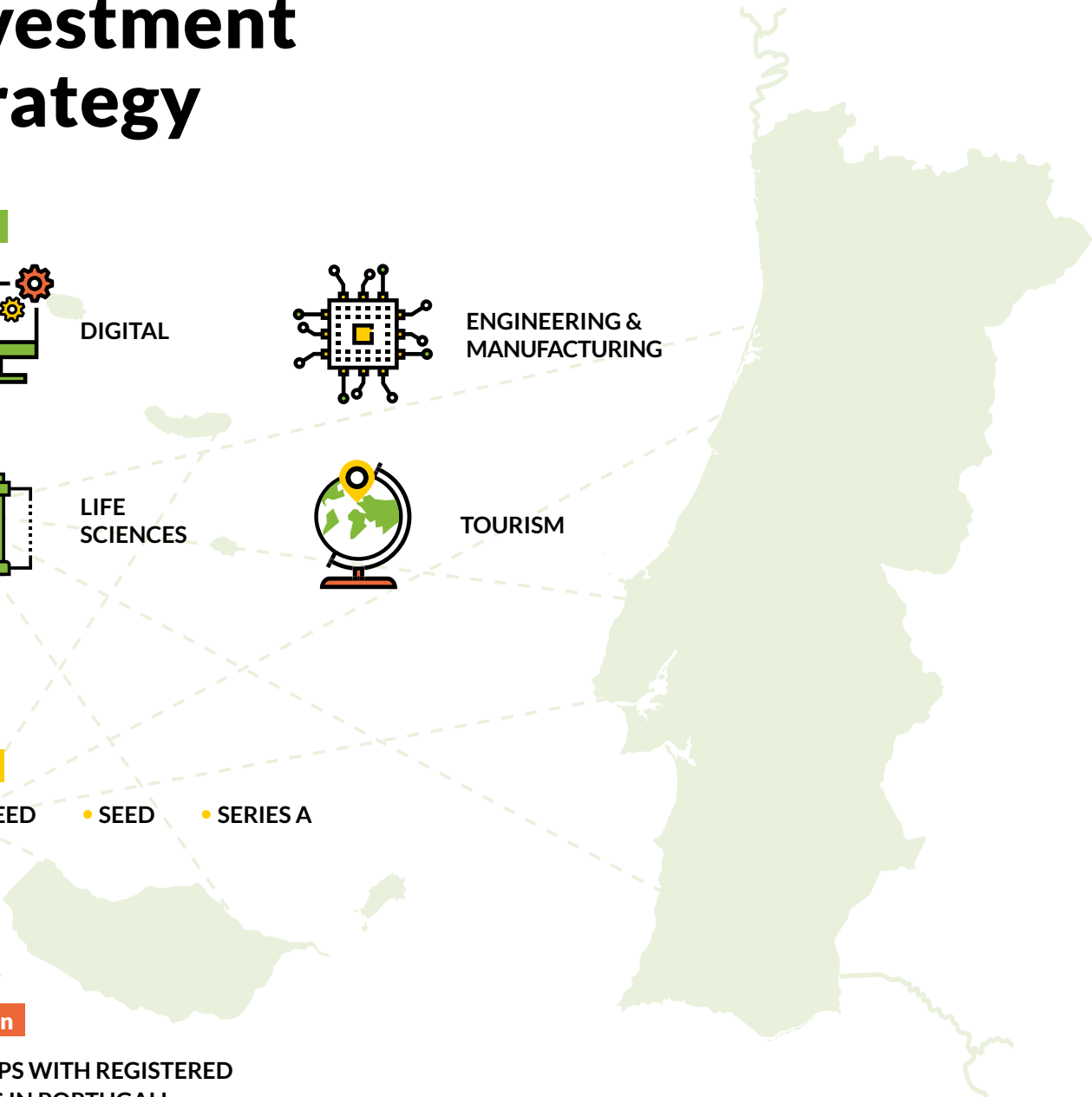
